 (c) Dividend Cover: the number of times that a company's earnings per share cover the net dividend payer.

 (d) Net Asset Value per Share: the NAV per Share is calculated by violiding the value of shareholders' funds with the number of shares in issue.

 (e) Earnings per Share: this sarrived at by dividing the company's priofit after tax (in the latest 12-month period) by the number of shares in issue.

- (f) Price/Earnings Ratio: this is calculated by dividing the current market price by the company's earnings per share achieved in its latest 12-month period.
