Net Asset Value per Share: The NAV per Share is calculated by dividing the value of shares haveholders' funds with the number of shares in issue.
Earnings per Share: this is arrived at by dividing the company's profit after tax (in the latest 12-month period) by the number of shares in issue.
Price/Earnings Ratio : this is calculated by dividing the current market price by the company's earnings per share at his latest 12-month period.
